As per CBB quidelines minimum balance charges on accounts, ad hoc/re-print statements, and over the counter cash withdrawals are waived for orphans, widows, pensioners, individuals receiving social subsidies from the ministry of labor & Social Development, students and Bahraini and non Bahraini nationals with monthly salary below BD 250.

No fee will be charged for liability letter addressed to Supreme Council for Women or Ministries or for Social Housing.

All fees and charges are inclusive of 10% Value Added Tax (VAT).
